Effective January 1, 2019

The Victoria County Clerk's Office will collect the following fees for filing instruments, which are required by law to be filed, and any cause of Court Action in Criminal, Civil and Probate. These fees are to be collected at the time of filing instruments or initiating a Court action.

## Requirements for the recording of documents relating to real property

### *Section 11.003, Property Code:*

- 1) An instrument executed after December 31, 1981, conveying an interest in real property may not be recorded unless:
  - a) a mailing address of each grantee appears in the instrument or in a separate writing signed by the grantor or grantee and attached to the instrument; or
  - b) a penalty-filing fee equal to the greater of \$25 or twice the statutory recording fee for the instrument is paid.
- 2) The validity of a conveyance as between the parties is not affected by a failure to include an address of each grantee in the instrument or an attached writing.
- 3) Payment of a filing fee and acceptance of the instrument by the county clerk for recording creates a conclusive presumption that the requirements of this section have been met.

### *Section 11.004(a), Property Code:*

- 1) A County clerk shall:
  - a) correctly record, as required by law, within a reasonable time after delivery, any instrument authorized or required to be recorded in that clerk's office that is proved, acknowledged, or sworn to according to law;
  - b) give a receipt, as required by law, for an instrument delivered for recording;
  - c) record instruments relating to the same property in the order the instruments are filed; and
  - d) provide and keep in the clerk's office the indexes required by law.

### *Section 11.008, Property Code:* (effective May 4, 2005)

- a) In this section, "instrument" means a deed or deed of trust.
- b) An instrument transferring an interest in real property to or from an individual and disclosing that individual's social security number or driver's license number must include a notice that appears on the top of the first page of the instrument in 12-point boldfaced type or 12-point uppercase letters and reads substantially as follows:

NOTICE OF CONFIDENTIALITY RIGHTS: IF YOU ARE A NATURAL PERSON, YOU MAY REMOVE OR STRIKE ANY OR ALL OF THE FOLLOWING INFORMATION FROM THIS INSTRUMENT BEFORE IT IS FILED FOR RECORD IN THE PUBLIC RECORDS: YOUR SOCIAL SECURITY NUMBER OR YOUR DRIVER'S LICENSE NUMBER.
- c) The validity of an instrument as between the parties to the instrument and the notice provided by the instrument are not affected by a party's failure to include the notice required under Subsection (b).
- d) The County Clerk may not under any circumstance reject an instrument presented for recording solely because the instrument fails to comply with the section.

### *Section 12.001, Property Code*

- 1) Instruments Concerning Property
  - a) An instrument concerning real or personal property may be recorded if it has been acknowledged, sworn to by proper jurats, or proved, according to law.
  - b) An instrument conveying real property may not be recorded unless it is signed and acknowledged or sworn to by the grantor in the presence of two or more credible subscribing witnesses or acknowledged or sworn to before and certified by an officer authorized to take acknowledgements or oaths as applicable.
  - c) This section does not require the acknowledgement or swearing or prohibit the recording of a financing statement, a security agreement filed as a financing statement or a continuation statement filed for record under the Business & Commerce Code.

### *Section 12.014, Property Code:*

- a) A judgment or part of a judgment of a court of record or an interest in a cause of action on which suit has been filed may be sold, regardless of whether the judgment or cause of action is assignable in law or equity, if the transfer is in writing.
- b) A transfer under this section may be filed with the papers of the suit if the transfer is acknowledged or sworn to in the form and manner required by law for acknowledgment or swearing of deeds.
- c) If a transfer of a judgment is filed, the clerk shall note the transfer on the margin of the minute book at the place where the judgment is recorded. If a transfer of a cause of action in which a judgment has not been rendered is filed, the clerk shall note and briefly state the substance of the transfer on the court docket at the place where the suit is entered.
- d) A transfer filed under this section is notice to and is binding on a person subsequently dealing with the judgment or cause of action.

### *Section 13.001, Property Code:*

- a) A conveyance of real property or an interest in real property or a mortgage or deed of trust is void as to a creditor or to a subsequent purchaser for a valuable consideration without notice unless the instrument has been acknowledged, sworn to or proved and filed for record as required by law.
- b) The unrecorded instrument is binding on a party to the instrument, on the party's heirs, and on a subsequent purchaser who does not pay a valuable consideration or who has notice of the instrument.
- c) This section does not apply to a financing statement, a security agreement filed as a financing statement, or a continuation statement filed for record under the Business & Commerce Code.

# Specifications for Filing and Recording of Legal Papers

(Sec 191.007 Local Government Code)

## Section 1.

(a) A legal paper presented to a county clerk for filing or for recording must meet the following requirements.

(b) A page is considered to be one side of a sheet of paper. A page must:

(1) be no wider than 8-1/2 inches and no longer than 14 inches;

(2) have a sufficient weight and substance so that printing, typing, or handwriting on it will not smear or bleed-through; and

(3) be printed in type not smaller than eight-point type and be suitable otherwise for reproducing from it a readable record by a photocopy or photo static or micro photographic process used in the office of the county clerk.

(c) A clearly identifying heading, similar to the headings on most commercially supplied printed forms, shall be placed at the top of the first page to identify the type or kind of legal paper.

(d) Printing and typing and handwriting shall be clearly legible.

(e) Names shall be legibly typed or printed immediately under each signature.

(f) All Photostats, photocopies, and other types of reproduction shall have black printing, typing or handwriting on a white background, commonly known as positive prints.

(g) Riders and attachments shall not be larger than the size of the page as defined in this article. Not more than one rider or attachment shall be included in or attached to a page.

(h) The filing fee or recording fee for each page of a legal paper that is presented for filing or recording to a county clerk and fails to meet one or more of the requirements prescribed by Subsections (b) through (g) is equal to twice the regular filing fee or recording fee provided by statute for that page. However, the failure of a page to meet the requirement prescribed by Subsection (b)(3) relating to type size does not result in a fee increase under this subsection.

(i) When a page or a legal paper has more riders or attachments than one, the filing fee or recording fee for each attachment in excess of one is twice the regular filing fee or recording fee provided by statute.

(j) When a page of a legal paper has one or more riders or attachments larger than the permitted size, a filing fee or recording fee for each oversized attachment is twice the regular filing fee or recording fee provided by statute for the attachment.

(k) This section does not authorize a county clerk to refuse to record a legal paper for the reason that it fails to meet one or more of the requirements prescribed by Subsection (b) through (g). Failure to comply with these requirements shall not in any manner alter, amend, impair, or invalidate any document or legal instrument of any type or character and upon recordation by the county clerk the document or legal instrument shall be deemed and considered as fully complying with the provisions of law dealing with the recordation of documents or legal instruments of every type and character.

Mail the Notice, with a copy of the Bond attached, to the Obligee by certified mail, return receipt requested, addressed to the Obligee (or Claimant) at the address stated in the Lien Affidavit.  
When certified mail receipt is returned served (green card), record a copy of the notice with return receipt (green card) attached.

**General Information for County Clerks Regarding Forfeiture Notices Affecting Contracts  
Appearing in the Deed Records**

Section 161.315 of the Natural Resources Code makes two requirements when the Veterans' Land Board resolves to forfeit delinquent contracts: (1) The Board must notify the County Clerks of the counties in which the forfeited contracts are recorded, and (2) the County Clerk shall enter a notation of the forfeiture on the margin of the page or pages containing the record of the original contract.

In some cases this presents a problem in that some counties use microfilm systems and cannot enter notations directly on the margin of the affected document. It is not the responsibility of the Board to advise the County Clerks how the requirement of the law in this regard should be satisfied; however, you may find the following information useful.

The sense and purpose of Section 161.315 seems to be to make sure that third parties examining the Deed Records should be put on notice that a particular contract has been forfeited thus severing all interest in the property on the part of the purchaser in that contract. The Board has complied with its obligation when notice of the forfeiture is furnished to the County Clerk. It is thereafter the clerk's obligation to make an entry into the Deed Records, which is sufficient to provide the notice of forfeiture. Where it is impossible to make a notation in the margin of the record of the document, the recordation of the enclosed notice itself would appear to satisfy the intent of Section 161.315. The Board must of course leave to the discretion of each County Clerk the best method for accomplishing the requirement made of the clerk by Section 161.315.

**General Information on Grants of the Veteran's Land Board**

You will note that the attached instrument does not bear the customary acknowledgements. For your information, **Title 1, Section 12.006** of the Property Code, formerly Article 6624 of Vernon's Civil Statutes of the State of Texas covering state grants read as follows:

"A grant from this state or the United States that is executed and authenticated under the law in effect at the time the grant is made may be recorded without further acknowledgement or proof."

By Attorney General's Opinion, Number WW-805, dated February 18, 1960, the Attorney General of Texas has indicated that in his opinion a conveyance from the Veteran's Land Board when executed and authenticated pursuant to Section 17, Article 5421m, V.A.C.S. (now Section 161.229 of the Natural Resources Code), is a "grant" within the meaning of the article quoted above and may be recorded without the customary acknowledgements. See also, Code Construction Act, Article 2429b-2, Section 3.11(c) and (d) Vernon's Civil Statutes.
