ORDER

WHEREAS, came on to be considered the petition filed on July 30, 2024, entitled “Village of Bloomington Incorporation Petition” in the Office of the County Judge of Victoria County, Texas. Specifically, the petition seeks to incorporate the proposed Village of Bloomington, Texas pursuant to Texas Local Government Code, section 8.002. Section 8.002 provides that “[t]he residents of a community may initiate an attempt to incorporate ... by filing with the county judge a written petition signed by at least 10 percent of the qualified voters of the community.” Tex. Loc. Gov’t. Code §8.002. Further, “[t]he petition must request the county judge to order an election to determine whether the community will incorporate as a Type C general-law municipality.” *Id.*

WHEREAS, if the “county judge receives the petition and if satisfactory proof is made that the community contains the requisite number of inhabitants, the judge shall order an incorporation election to be held on a specified date and at a designated place in the community.” Tex. Loc. Gov’t. Code §8.003.

THEREFORE, it is ORDERED that the petition seeking an election to incorporate the proposed Village of Bloomington fails to meet the statutory requirements and satisfactory proof has not been made to the County Judge of Victoria County, Texas and the petition is denied.

**Re: Incorporation Petition:
*Village of Bloomington***

Honorable Judge Zeller:

I am honored to submit to you the enclosed petition calling for a municipal incorporation election of the Bloomington community as a Type C general-law municipality to be known as the "Village of Bloomington."

I am submitting the enclosed petition on behalf of the petition signers and 87204EDC, Corp., a nonprofit formed by local residents advocating for the incorporation of their community. This petition has been signed by 121 residents of Bloomington who seek to put the proposed incorporation before the voters of their community in the November 2024 election.

We respectfully request that you order a special election on the incorporation proposition and for the initial election of Village officers to be held on November 5, 2024. The special election should be ordered by or before August 19, 2024.¹

The enclosed petition of the residents of Bloomington is submitted to you as provided for under Chapter 8 of the Texas Local Government Code, which governs the process for the proposed incorporation of Bloomington as a Type C general-law municipality.

Under state law, if a county judge receives a petition signed by 10% of the qualified voters of the community and satisfactory proof is made that the proposed municipal boundaries contain the requisite number of inhabitants, the county judge shall order an incorporation election to be held.² Furthermore, at the same time as the incorporation election, a mayor and two commissioners must be elected as the initial governing body of the proposed Village.³ The

county judge shall appoint two election judges and two election clerks to conduct the incorporation election.⁴ If a majority of the votes cast in the November 2024 election are for incorporation, the county judge shall enter an order into the minutes of the commissioners court that the community is incorporated.⁵

As you are aware, Bloomington is a community that is over a century old. The residents of the community have a strong sense of identity and share common values and goals. The area has grown and developed to the point where its citizens need the benefit of planned and responsible growth to protect their quality of life and preserve community assets. Incorporating the community will provide a voice to protect the residents' interests. In turn, the petitioners are willing to assume the burden and responsibility that comes with operating a municipality.


The enclosed petition includes a map of the proposed municipal boundaries for the Village of Bloomington. Based on U.S. Census data, there are estimated to be 511 inhabitants within the proposed municipal boundaries. This meets the population requirement for incorporation.⁶ The proposed municipal boundaries include an area of 1.11 square miles, which meets the territorial requirements for incorporation.⁷

The petition is signed by 121 registered voters of Bloomington, who reside within the proposed municipal boundaries. The minimum requirement under state law is that the petition must be signed by at least 10% of the registered voters who reside within the proposed municipal boundaries.⁸ Based on a recent list of registered voters obtained from Victoria County, to the best of our knowledge there are 450 registered voters listed with addresses within the proposed municipal boundaries. The 121 petition signatures exceed the 10% requirement of 45 signatures.

In addition to the petition, we are pleased to provide you with supporting documents included as enclosures to this letter. If you have any questions regarding the enclosed petition or supporting documents, please do not hesitate to contact me.

I appreciate your cooperation in ensuring that the election is timely ordered so that the voters of Bloomington may have the opportunity to consider and decide the matter of incorporation for themselves in the November 2024 election.

Petition Calling Incorporation Election for Bloomington

WHEREAS, the undersigned request an election on the issue of whether the historic community commonly known as "Bloomington" should be incorporated as a Type C general-law municipality; and

WHEREAS, the undersigned request a concurrent election to select a Mayor and two Town Commissioners; and

WHEREAS, Bloomington is an unincorporated community dating over a century, which has a strong sense of identity, an assemblage of inhabited residences, a compact center of population around which an unincorporated town has developed, and some degree of unity and proximity between the residences so to constitute a town capable of providing and susceptible to receiving some reasonable level of municipal services; and

WHEREAS, the proposed name of the municipality will be the "Village of Bloomington"; and

WHEREAS, the proposed boundaries of the municipality are shown on the plat (i.e., map) attached as Exhibit A, which contains only the territory to be used strictly for municipal purposes; and

WHEREAS, the undersigned constitute ten percent (10%) or more qualified (i.e., registered) voters who are residents of the proposed municipality; and

WHEREAS, the proposed municipality contains less than two square miles of surface area; and

WHEREAS, the proposed municipality contains more than 201 inhabitants and less than 4,999 inhabitants; and

WHEREAS, the proposed municipality is located entirely in Victoria County, Texas; and

WHEREAS, the proposed municipality is not located in the extraterritorial jurisdiction (ETJ) of any other municipality; and

WHEREAS, this petition is made pursuant to the laws of the State of Texas, particularly: Article XI, Section 4 of the Constitution; Chapters 5, 8 and 24 of the Local Government Code; and Chapter 277 of the Election Code.

NOW THEREFORE, the undersigned respectfully petition the Honorable Ben Zeller, County Judge of Victoria County, Texas, and request that he order a special election on the issue of incorporation of Bloomington as a Type C general-law municipality and a concurrent election to select a Mayor and two Town Commissioners, to be held at a designated place in Bloomington on the next uniform election date, November 5, 2024.
